

• **Nabil Sadoun:** A CAIR board member, co-founded UASR with Hamas leader and fugitive Marzook. The Justice Department added UASR to the list of unindicted co-conspirators in the Holy Land case. In 2010, Sadoun was ordered deported to his native Jordan.

• **Mohamed Nimer:** A CAIR research director also served as a board director for UASR, whom the Justice Department listed as an unindicted co-conspirator in the HLF trial.

• **Rafeeq Jaber:** A founding director of CAIR, Jaber was the long-time president of the Islamic Association for Palestine. In 2002, a federal judge found that “the Islamic Association for Palestine has acted in support of Hamas.”

• **Rabith Hadid:** The CAIR fundraiser was a founder of the Global Relief Foundation, which after 9/11 was blacklisted by the Treasury Department for financing al-Qaida and other terror groups. Hadid was arrested on terror-related charges and deported to Lebanon in 2003.

• **Hamza Yusuf:** The FBI investigated Yusuf, a CAIR board member after 9/11, because he made an ominous prediction to a Muslim audience two days before the attacks. “This country is facing a terrible fate, this country stands condemned.”

• **Mohammad El-Mezain:** the former chairman and director of endowments for HLF, conducted fundraising at a 2004 CAIR New York event, soliciting over \$100,000 for CAIR. Indicted soon afterward for providing material support to Hamas.

CAIR’s founder, **Omar Ahmad**, while claiming to be a moderate and patriotic American, is reported to have told a group of Muslims in Northern California in 1998 that “they” are in

America not to assimilate, but to help assert Islam’s rule over the country.

“Islam isn’t in America to be equal to any other faith, but to become dominant,” a local reporter paraphrased him as saying.

An FBI wiretap transcript quotes Ahmad agreeing with terrorist suspects gathered at the secret Philadelphia meeting (in 1993) to “camouflage” their true intentions.

“This is like one who plays basketball: He makes a player believe that he is doing this, while he does something else. Like they say, politics is a completion of war.”

WHY ARE SO MANY CAIR LEADERS TERROR CRIMINALS?

The Council on American-Islamic Relations, (CAIR), was labeled an unindicted co-conspirator in the Holy Land Foundation Trial by the government of the United States of America. That's a huge indictment! The Holy Land Foundation for Relief and Development, was a Texas based Muslim charity that was found guilty of conspiracy to provide material support and resources to Hamas -- a known terrorist organization.

Many CAIR leaders and officials had close connections to the HLF and through trial evidence was shown to be a Muslim Brotherhood / Hamas front group -- working within the United States. Due to that material fact and its well documented criminal activities and history, the FBI no longer teams with CAIR for Muslim outreach.

This brochure takes a closer look at several current and former CAIR leaders / officials who are currently convicted CRIMINALS, or under investigation or under suspicion for having links to Jihadist terror groups and activities.

Islam as Common Denominator

CAIR is often viewed as the public face of Islam in America with it's spokespersons on television and in the media defending Muslims and the Islamic worldview from detractors.

CAIR is often defending Muslims accused of terror related activities and yet, even after so many convictions of their own leadership, they

appear to be teflon coated, unharmed by this shameful fact, that CAIR = HAMAS.

When CAIR is at work -- truth and justice are often the ultimate victims!

Lets look at some CAIR leaders who not only publically defend radical Islam, they have been convicted of being part of radical Islam.

- **Ghassan Elashi:** A Founding CAIR Director, Elashi is related to Hamas leader Mousa Abu Marzook. Elashi and his four brothers were convicted of terror related charges, stemming from "conspiracy, and money laundering."

- **Muthanna al-Hanooti:** A CAIR Director. "Al-Hanooti collected over \$6 million in support of Hamas." His home and offices were raided by the FBI in a terror investigation. Al-Hanooti is related to Sheik Mohammed al-Hanooti, an unindicted co-conspirator in the 1993 World Trade Center bombing. He has praised Palestinian suicide bombers as "martyrs."

- **Abdurahman Alamoudi:** A CAIR Director in Federal prison for plotting terrorism. Alamoudi, was a top fundraiser in America for al-Qaeda, according to the U.S. Treasury Department.

- **Siraj Wahhaj:** CAIR board of advisers, Wahhaj was named as an unindicted co-conspirator in the 1993 World Trade Center bombing.

- **Randall "Ismail" Royer:** Former CAIR communications specialist – serving 20 years

in prison for helping get Jihadists to a terror (*Lashkar-e-Taiba*) training camp in Pakistan.

- **Bassam Khafagi:** CAIR director of community affairs, pleaded guilty to bank fraud charges stemming from a federal counter-terror probe. He served 10 months in prison, then was deported to his native Egypt.

- **Laura Jaghlit:** CAIR civil-rights coordinator was investigated for money laundering and tax fraud. Her husband Mohammed Jaghlit, a leader in the Saudi-backed SAAR network, is a target of an active investigation. Jaghlit was named an unindicted co-conspirator in the Holy Land Foundation trial.

- **Nihad Awad:** Evidence from the Holy Land case puts CAIR executive director at the 1993 Philadelphia meeting of Hamas leaders and activists that was recorded by the FBI. Participants hatched a plot to disguise payments to Hamas terrorists as charitable giving. Awad's phone number is listed in a Muslim Brotherhood document seized by federal investigators revealing "important phone numbers" for the "Palestine Section" of the Brotherhood in America. The court exhibit showed Hamas fugitive Mousa Abu Marzook listed on the same page as Nihad Awad. Birds of a feather? Of course they flock together!

- **Omar Ahmad:** U.S. prosecutors named CAIR founder and chairman emeritus as an unindicted co-conspirator in the Holy Land case. Prosecutors designated him as a member of the Muslim Brotherhood's "Palestine Committee" in America. Ahmad, like Awad, is Palestinian. Hmmm...coincidence?
