

employers have been forced to accommodate hostile Islamic customs and rites to the detriment of productivity and equal treatment of all employees. All of these incursions are the work of Muslim Brotherhood affiliates.

3. Expanding the observant Muslim base

The expansion of mosques in the United States far outpaces the increase in the Muslim population. The number of Muslims increased about 25 percent between 1989 and 1998, but the number of mosques tripled. Mosques are strategically-distributed bases of operations for advancing the Islamic agenda.

4. Unifying and directing Muslims' efforts

While there are arguably many different expressions of Islam in America, the Muslim Brotherhood affiliates vigorously suppress and exclude those alternative voices from the public debate about Islam. Two moderate Muslim organizations that are rarely allowed to speak for Muslims are the American Islamic Forum for Democracy (Dr. M. Zuhdi Jasser) and the Free Muslims Coalition (Kamal Nawash). Never heard of them, right?

5. Presenting Islam as a civilizational alternative

Brotherhood affiliates are becoming bolder in injecting their religious superiority into Christian churches and communities. In 2012, the Muslim Public Affairs Council held their annual convention at the All Saints Episcopal Church in Pasadena, CA. Their founder, Dr. Maher Hathout, proclaimed from the pulpit, "Our job is to make Muslims better people. What would be better than the Laws of Allah [i.e., Sharia Law]?" In August, 2015, a Muslim exercised his legal right to open the Lincoln County, NC, Board of Commissioners Meeting with an Islamic prayer that included Al-Fatihah (Surah 1 of the Quran) which includes these words: "Show us the straight way [meaning Sharia]. . . not the (path) of those who earn Thine anger [meaning Jews] nor of those who go astray [meaning Christians]." Of those who embrace a religious

faith in Lincoln County, 98.5 percent are Christian. As a result of this outrageous prayer, the Lincoln County Board immediately voted to scrap all invocations and institute a moment of silence instead.

6. Supporting the establishment of the global Islamic State wherever it is

In 2015, the United States has seen an increased number of jihadist volunteers leaving to support ISIS or the Islamic State in the Middle East. None of the Muslim Brotherhood organizations has denounced this movement, although they often equivocate by saying that ISIS doesn't represent Islam. Wrong. An August, 2014, Washington Times article quoted unnamed senior U.S. officials stating that the number of Americans fighting side-by-side with ISIS was 300. Since then, there has been no official reporting on these home-grown terrorists. Intuitively, the figure has grown considerably. Those returning veterans of jihad in the Middle East pose a real threat to the security of the United States. Recall that just 19 fanatical Muslims were able to destroy the World Trade Center and part of the Pentagon, killing almost 3,000 people.

The Muslim Brotherhood has not only outlined its long-range plan for destroying America, but they are making significant progress toward that goal. Americans need to wake up, get educated about the threat of Islam to our civilization, and take action to oppose their encroachment wherever it occurs.



The Enemy's Plan For All To See

What is Islam?

Islam is defined by the holy texts of its religion – not by the beliefs, actions or virtues of a Muslim.

Already twenty-five years ago, the Muslim Brotherhood drafted a plan to destroy the United States as a major step in establishing a global Islamic State (Caliphate). Still, few Americans are aware of this written plan of attack or the progress the Muslim Brotherhood has made in the past quarter century.

If you think that Islam has not declared us to be their enemy or if you think the major Muslim organizations in the U.S. have only peaceful intentions, this brochure will probably startle you. We're not "Islamophobes" or Chicken Little "the sky is falling" alarmists. But when the enemy has a written plan of action on which they are progressing, rational Americans who love their freedom need to be aware of the threat of Islamic Jihad and the encroachment of Islamic Shariah Law.

It Began with Funding Islamic Terrorism

When the U.S. government prosecuted and convicted five officers of the Holy Land Foundation in November, 2008, in the largest terrorism funding case in history (involving some \$12.4 million), they introduced into evidence a 1991 document titled "An Explanatory Memorandum on the General Strategic Goal for the [Muslim Brotherhood] Group in North America." This document is basically the enemy's plan for taking over the United States – not with guns or bombs – instead, by stealth and infiltration. Here is their plan in their own words:

"The [Muslim Brotherhood] must understand that their work in America is a kind of grand Jihad in eliminating and destroying the Western civilization from within and 'sabotaging' its miserable house by their hands and by the hands of the [Muslim] believers so that it is eliminated and [Allah's] religion is made victorious over all other religions." Implementing the plan in "milestones"

One of the main ideologues of the Muslim Brotherhood is Sayyid Qutb (1906-1966) whose seminal book, "Milestones," cautioned the Brotherhood to take small, incremental steps in establishing their Islamic superiority. He wrote, "The correct procedure is to mix [with non-Muslims] with discretion, give and take with dignity, speak the truth with love, and show the superiority of the [Islamic] faith with humility. The chasm between Islam and *Jahiliyyah* [ignorance] is great, and the bridge is not to be built across it so that people on the two sides may mix with each other, but only so that the people of *Jahiliyyah* may come over to Islam . . . and may get rid of their miserable condition. . . . The struggle between the [Muslim] Believers and their enemies is in essence a struggle of belief and not in any way of anything else." (pp. 140 and 159) In the Muslim Brotherhood plan, these milestones are called "elements," necessary steps to achieve the over-all objective. Each element is described below along with the progress being made toward accomplishing it.

1. Establish and effective and stable Islamic Movement led by the Muslim Brotherhood

Most Americans are unaware of the large network of seemingly innocuous organizations that form the Muslim Brotherhood in the United States. The MB plan lists twenty-nine such associated organizations, including the Council on American Islamic Relations (using its original name, Islamic Association for Palestine), the Islamic Society of North America, Muslim Students' Association, the International Institute for Islamic Thought, and the North American Islamic Trust.

To help understand the reach of these organizations, the **Council on American-Islamic Relations (CAIR)** is the principal lobbying and political advocacy branch of the MB. It has offices in 33 cities across the nation and operates with an annual budget of over \$3 million. Much of their funding comes from unidentified foreign sources.

Who is a Muslim?

A Muslim is one who is obedient to the commands of Allah and examples of Muhammad.

The **Muslim Student Association** is the wing of the MB that unites Muslim students in establishing Islamic priorities on high school and college campuses. Today they have 600 chapters on campuses across the nation, even at Christian colleges such as Wheaton College in Illinois. Unfortunately, the MSA has also been the breeding ground for young terrorists. This is a short list of well-known terrorists who were former members of the Muslim Student Association: Anwar al-Awlaki, Ramy Zamzam, Abdurahman Alamoudi, Ali Asad Chandia, and Omar Hammami.

The **International Institute of Islamic Thought** is the branch of the Muslim Brotherhood concerned with coordinating and unifying doctrinal issues. This wing has given its endorsement to "Reliance of the Traveller" as the approved source-book for Islamic Sharia Law. They also coined the word "Islamophobia" in 1991 as a tool to suppress free speech about Islam.

The **North American Islamic Trust** is the financial wing of the Muslim Brotherhood. In 2000 they had funded an estimated 27% of 1,209 Mosques in the United States. They hold title to about one in four mosques here. They also provide Sharia compliant investments and loans. Their assets amounted to over \$35 million in 2003.

2. Adopting Muslims' causes domestically and globally

The slow insinuation of Islamic Sharia Law into our secular democracy is almost imperceptible – like boiling a frog. However, Americans are realizing that no other religion has demanded and received so many special prerogatives: the U.S.'s "war on terror" has been purged of all references to Islam; many public figures have been sued or humiliated for their comments linking Islam to terrorism; schools have caved in to providing segregated swimming pools, halal meals, and special dispensation for Muslim prayers and holidays;
