

7) honor murder – Koran 18:74 and 18:80, 01.2(4)

On New Year's Day, 2008, two teenage Egyptian-American sisters, Amina (18) and Sarah Said (17), were shot dead in Irving, Texas. Their father, Yaser Abdel Said, reportedly was angry with their American-like behavior, which included dating. The great-aunt called the murders "honor killings" for bringing shame to the family. The father escaped prosecution.

Note: References above are to the Koran and to the Classic Manual of Islamic Sacred Law (*Reliance of the Traveler*), approved by the International Institute of Islamic Thought, Herndon VA and in agreement with 75 percent of all of the Sunni schools of Islamic jurisprudence.

These acts of violence are all against the law in the United States, but they are often overlooked out of deference for religious beliefs. With the exception of terrorism, these crimes are rarely prosecuted, which allows Muslims to engage in them with impunity.

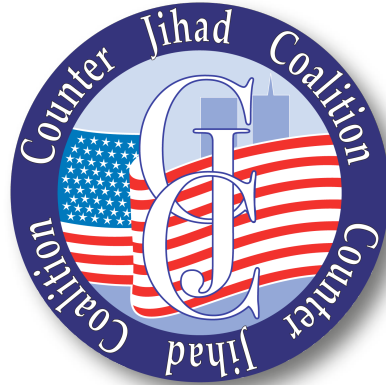
What Can You Do?

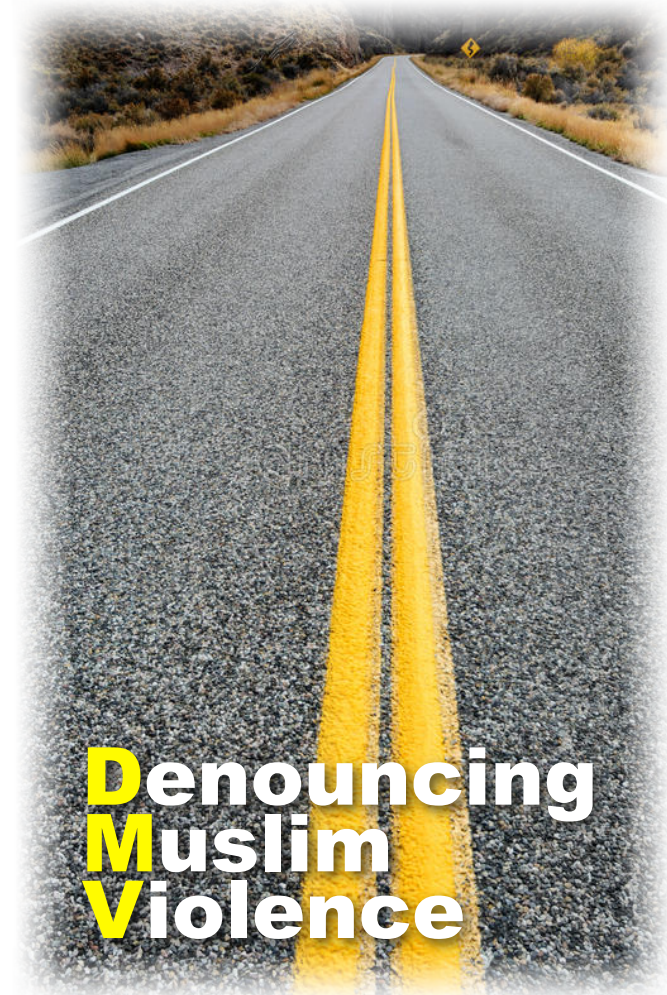

What is Islam?

Islam is defined by the holy texts of its religion - not by the beliefs, actions or virtues of a Muslim.

More important than your **car** or your **license** is a new threat we have in the United States, **Muslim Violence**. This brochure is about **Denouncing Muslim Violence**. Americans have become so politically correct that they give Muslims a “pass” regarding their violent behavior since Islam is a religion. Because we don’t want to be called bigots or racists, we are tolerating new kinds of violence which are undermining our country and our value system.

Seven Kinds of Muslim Violence -- Muslim violence includes things that wouldn’t occur to you, all driven by Islamic Sharia Law. Muslims are a bit embarrassed about some of the draconian aspects of Sharia Law, so they actually deny they practice it. Here is a brief summary of violent Sharia Law and its manifestations in the United States:

1) terrorism (jihad) – Koran 8:59 and 9:29, o9.8

On December 2, 2015, in San Bernardino, California, 14 people were killed and 22 others were seriously injured in a terrorist attack consisting of a mass shooting and an attempted bombing at a Christmas party of the terrorist’s co-workers. The perpetrators, Syed Rizwan Farook and Tashfeen Malik, a couple who married in Saudi Arabia and were living in the city of Redlands with their infant child. Malik was a recent immigrant who abandoned her 6 month old child to engage in terrorism. Over 158 Americans have been killed by Islamic terrorism since 9/11/2001.

2) wife beating – Koran 4:34, m10.12

Two months into an arranged marriage, FoZIA Sadiq, a young Pakistani immigrant, found herself trapped in the suburbs of Dallas, Texas, with a violent husband. She says he routinely beat her and intimidated her into never going anywhere in public without him. Sadiq finally escaped in 2006. It was when she was on the ground [during the beating], that she finally decided to leave – before he killed her. Now she is struggling to divorce her husband and remain in the U.S. (A court case of Mazna Hussain)

3) forced marriage of under-age girls (i.e., rape) – Koran 65:4, m3.13(1) and n9.2

In a New Jersey case, a young bride, S.D., petitioned for a restraining order against husband, M.J.R., who was forcing her to have sex against her will. The rapes and domestic violence took place in 2008, and on the night of January 15, 2009. While raping the woman, the Muslim man said “You are my wife, I can do anything to you. The woman, she should submit and do anything I ask her to do.” The bride was only 17, and was imported from Morocco as a teenage bride in an arranged marriage having never seen her husband prior to the wedding. The husband was not some immigrant day laborer but an accountant fully familiar with American laws and customs. In the initial court case, the judge ruled against S.D.’s request, stating that the husband thought it was his right to rape her. (This ruling was later overturned on appeal.)

4) female genital mutilation – e4.3

In June 2017, Tahera Shaffiq, a Detroit-area mother was arrested for assisting in the female genital mutilation of two seven year old girls from Minnesota. The mutilation was performed

by a Detroit-area doctor, Jumana Nagarwala, who was also arrested. Female genital mutilation is the cutting of part of a girl’s genitals and has been illegal in the United States for decades, but this is the first federal case of its kind. It is estimated that over 500,000 girls have been mutilated or are at risk to FGM in the United States.

5) death for apostasy – Koran 4:89, o8.1

The best known American apostate from Islam is Ayaan Hirsi Ali, who left Islam in 1992 to avoid an arranged marriage to a cousin she never met. Later she rose to a seat in the Dutch Parliament and helped produce a short film on Islam with Theo Van Gough, titled “Submission.” When Van Gough was stabbed to death in broad daylight in 2004, a long note pinned to him predicted Ayaan would be next. It said, “I surely know that you, O Hirsi Ali, will be destroyed.” She has had to live under armed protection ever since. Ayaan moved to the U.S. in 2006.

6) religious vigilantism (no-go zones) -- Koran 3:104, q1.0 – q6.3

In June, 2016, Omar Mateen attacked Pulse, a gay nightclub in Orlando (FL) killing 49 people and wounding another 53. At that time it was America’s deadliest terror attack since 9/11/01. While Mateen pledged loyalty to ISIS and said the attack was revenge for the U.S. killing of Abu Waheeb in Iraq the previous month, his targeting gays for punishment would surely win favor and sympathy among fellow Muslims. Homosexuality is an “enormity” in Sharia Law, punishable by death. (p17.3)
